These notes follow the #HardwickeBrew given by Hardwicke's Property Team on 7th May 2020 which looked at remote hearings in property disputes, and how the courts and tribunals are adapting so as to enable property-related disputes to be determined during lockdown. All the information below was correct as at 7th May 2020.

Remote Hearings

A regularly updated list of open, staffed and suspended courts and tribunals during the coronavirus outbreak

Remote Hearing Protocol https://bit.ly/2xWmBrW

A 'flexible' protocol which applies to all trials, applications and all hearings in all Civil Courts (but not tribunals), which encourages hearings to take place remotely

Confirms that hearings should, as far as possible, be held in public. (including enabling media to access the hearing if requested)

Confirms that hearings will be recorded by the court (unless recording dispensed with). Parties not permitted to record hearings themselves.

PD is coterminous with the Coronavirus Act 2020 and provides the legal basis for the guidance within the Remote Hearing Protocol

Pilot Protocol for FtT and UT https://bit.ly/3b2Pi4r

A new Pilot Protocol for all Tribunal (incl Upper Tribunal) hearings

If rules permit decisions on paper, this should be the usual method

A triage scheme will be used in cases where a party insists on an oral hearing, whereby:

- Tribunal makes a 'provisional' decision on the papers and parties will be asked to confirm whether or not they consent to a binding decision on this basis
- If either party requests an oral hearing, a hearing will be listed (which may be conducted remotely)

Hearings should be conducted remotely if in accordance with overriding objective

Site inspections can be conducted as 'drive-by' or via photographs or videos
